If at any stage of selection the UPSC is of the opinion that sufficient no. of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.</p> <p>(The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of the Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.</p> |

The eligible officers should apply for the aforesaid posts and also forward their applications through their department. While forwarding the applications of the eligible officers, the concerned department should furnish the following document and certificates:-

- (ii) Attested copies (on each page of ACRs/APAR) for the last five years.
- (iii) Cadre clearance, Integrity Certificate, Vigilance Clearance Certificate and statement of major/minor panalties if any, imposed on the candidate during the last 10 years, in original or no penalty certificate, as the case may be forwarded duly signed & stamped by the Competent Authority.
- (iv) Certificate regarding no court case is pending against the officer concerned.

Officer who apply for the post will not be allowed to withdraw their candidature at a later stage. Application not received through proper channel or after the due date or without the above mentioned documents will be rejected.

Note- The candidates who have earlier applied to the said posts of Architects on deputation basis against the vacancy published in the Employment Newspaper edition dated 5-11 March, 2022 need not to apply again. However, they should submit remaining documents, if any, within the stipulated time limit.

The suitable and willing officers must apply through proper channel within 60 (Sixty) days from the Publication of this advertisement in the '**Employment News**'.
